ABOUT THIS QUESTIONNAIRE

This questionnaire is a part of the Health and Retirement Study. We greatly value your past participation in the HRS, and we hope that you will find this questionnaire interesting to complete. As always, your answers are extremely important to us. Please remember that your participation is *voluntary* and that you may skip over any questions that you would prefer not to answer.

A Department of Health and Human Services Certificate of Confidentiality covers this research in order to help ensure your privacy. This certificate can help protect the investigators from being forced to release any research information that identifies you. Please note that we must report credible evidence of serious harm or abuse to any person to the authorities, but this questionnaire does not ask any questions about such topics.

The questions are about expenses for your children's schooling. How many children and step-children do you have, including any children who died after age 18? _____.
If this number is **1 or more**, please continue; **if 0**, please return this questionnaire to us.

For those of you with one or more children who lived to at least age 18, we suggest that the member(s) of the household most knowledgeable about the topics be involved in completing the questionnaire. At the end of the questionnaire, there is a place where you can tell us who actually answered the questions.

On the following pages, we ask you to answer a few questions about each of your children. The first name of each child that you have told us about in a previous interview is printed at the top of the page. If the name of a living child is missing, write his or her name below the tear-off strip in one of the blank columns. Please also add the names of any deceased children who lived to age 18. Note that we are asking people to answer the questions for ten children at the most, so there is no need to add children if ten are already listed.

Answer the questions for the first child by filling out the first column before continuing on to the next child in the second column. The instructions in parentheses will help guide you through the questionnaire.

An example of a completed questionnaire is provided on the following page.

When a question asks for an amount, such as a percentage or age, please write down the number that is your best estimate, or a range of numbers. Do not use words, like “many,” “most,” or “all.”

When a question uses the word “you,” we mean your spouse at the time, as well. You may wish to consult your spouse or look at financial records as you answer the questions.

Question H7 asks for the name of the college from which the child graduated. If the child did not graduate, you should write the name of the college he or she attended the longest. If the longest period is the same for more than one college, name the most recent of these.

When you are thinking about payments you made for a child’s education, please do not include any money that you lent to your child that was later repaid to you.

After you have answered the questions for all of your children, please tear off the perforated strip at the top of the form to remove their names before returning the questionnaire.
